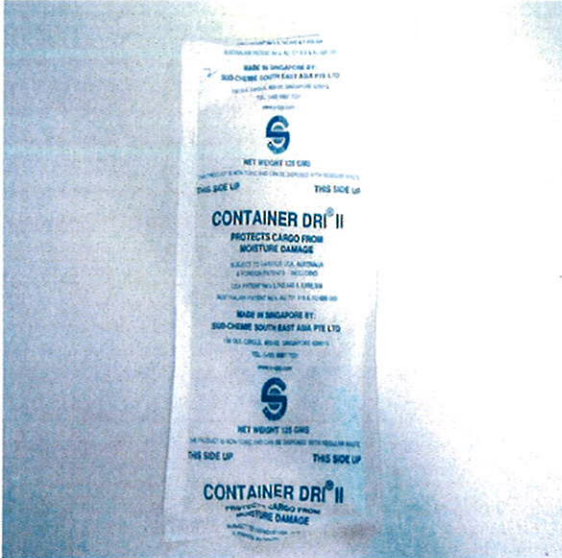

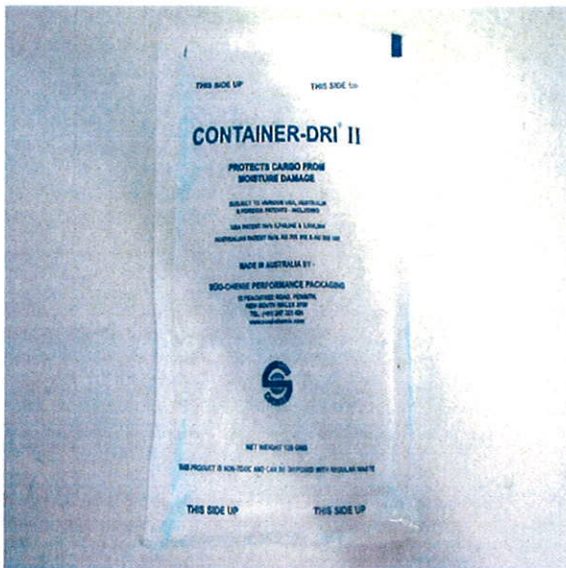
Container DRI II Singapore
