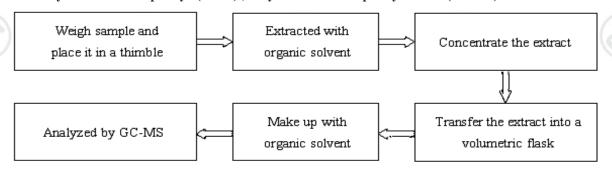
2. Mercury (Hg)

4. Polybrominated Biphenyls(PBBs), Polybrominated Diphenyl Ethers(PBDEs)



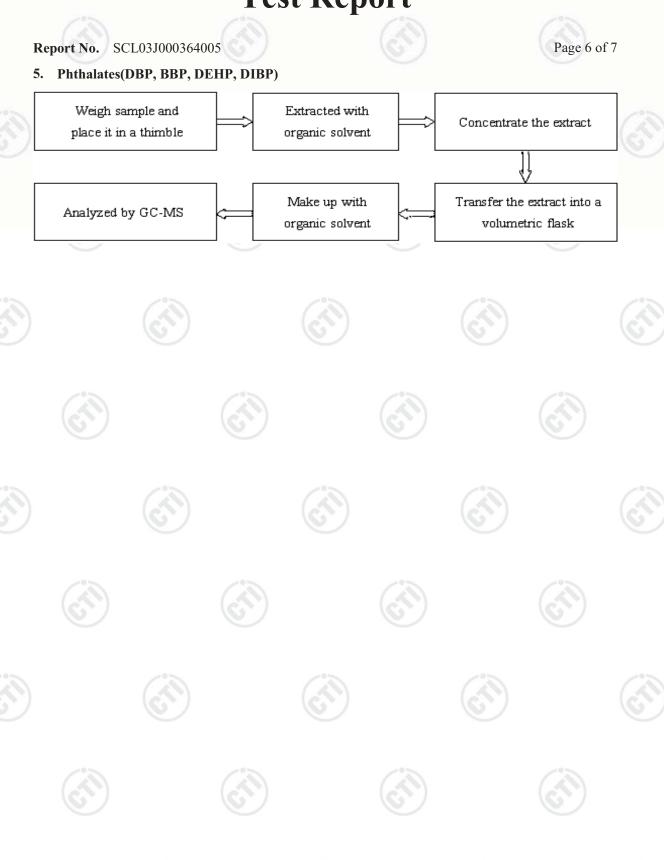

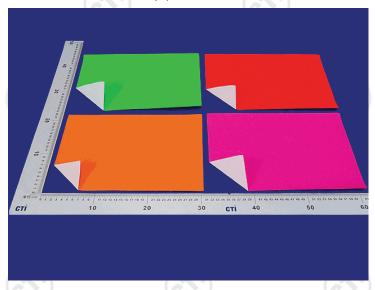
